OWSIC & IEOP

The QLD government introduced the concept of Indigenous Economic Opportunity Plans (IEOP) to maximise local employment, training and business supply opportunities for Aboriginal and Torres Strait Islander Queenslanders in connection with local eligible building and construction projects. This commitment by the QLD government is supported by relevant policy and is incorporated into written agreements between the QLD government and preferred

OWSIC's principals have been involved in the delivery of IEOP's since 2014 on projects in both the NPA and TSI regions.
